COMPANY DETAILS

The Indian Air Force (IAF) is the air arm of the Indian Armed Forces. Its primary mission is to secure Indian airspace and to conduct aerial warfare during armed conflicts. It was officially established on 8 October 1932 as an auxiliary air force of the British Empire which honoured India's aviation service during World War II with the prefix Royal. On 11 May 1999, the Indian Air Force was called in to provide

close air support to the Indian Army at the height of the ongoing Kargil conflict with the use of helicopters. The IAF strike was code named Operation Safed Sagar. The first strikes were launched on 26 May, when the Indian Air Force struck infiltrator positions with fighter aircraft and helicopter gunships. The initial strikes saw MiG-27s carrying out offensive sorties, with MiG-21s and later MiG-29s providing fighter cover. The IAF also deployed its radars and the MiG-29 fighters in vast numbers to keep check on Pakistani military movements across the border. Srinagar Airport was at this time closed to civilian air-traffic and dedicated to the Indian Air Force.



On 27 May, the Indian Air Force suffered its first fatality when it lost a MiG-21 and a MiG-27 in quick succession. The following day, while on an offensive sortie, a Mi-17 was shot down by three Stinger missiles and lost its entire crew of four. Following these losses the IAF immediately withdrew helicopters from offensive roles as a measure against the threat of Man-portable air-defence systems (MANPAD). On 30 May, the Mirage 2000s were introduced in offensive capability, as they were deemed better in performance under the high-altitude conditions of the conflict zone. Mirage 2000s were not only better equipped to counter the MANPAD threat compared to the MiGs, but also gave IAF the ability to carry out aerial raids at night. The MiG-29s were used extensively to provide fighter escort to the Mirage 2000. Radar transmissions of Pakistani F-16s were picked up repeatedly, but these aircraft stayed away. The Mirages successfully targeted enemy camps and logistic bases in Kargil and severely disrupted their supply lines. Mirage 2000s were used for strikes on Muntho Dhalo and the heavily defended Tiger Hill and paved the way for their early recapture. At the height of the conflict, the IAF was conducting over forty sorties daily over the Kargil region. By 26 July, the Indian forces had successfully repulsed the Pakistani forces from Kargil. The Indian Air Force, with highly trained crews, pilots, and access to modern military assets provides India with the capacity to provide rapid response evacuation, search-and-rescue (SAR) operations, and delivery of relief supplies to affected areas via cargo aircraft. The IAF provided extensive assistance to relief operations during natural calamities such as the Gujarat cyclone in 1998, the tsunami in 2004, and North India floods in 2013

Pursuant to the New HR methodology for induction of Agniveervayu under 'Agnipath Scheme', aimed to provide an opportunity to Nation's youth to experience military way of life for a period of four years, Indian Air Force invites ONLINE applications from unmarried Indian male and female candidates for selection test from 17 March 2024 onwards to join the IAF as an AGNIVEERVAYU. The number and employability of female candidates will be decided as per service requirement.

(THE SELECTION TEST IS NOT FOR SELECTION AS COMMISSIONED OFFICERS/ PILOTS/ NAVIGATORS/AIRMEN)

2. Application is required to be filled only ONLINE by the candidates and detailed instructions to fill up the same are available at https://agnipathvayu.cdac.in.

3. This examination is valid for AGNIVEERVAYU INTAKE 01/2025.

ONLINE REGISTRATION shall commence at 1100h on 17 January 2024 and will close at 2300h on 06 February 2024. Only ONLINE REGISTERED applications shall be accepted. For registration log on to https://agnipathvayu.cdac.in

Note: - Candidates are advised to register at the earliest opportunity as no extension of registration dates will be accommodated

ELIGIBILITY CRITERIA

5. <u>Age</u>.

Date of Birth Block. Candidate born between 02 January 2004 and 02 July 2007 (both dates inclusive) are eligible to apply. (a)

In case, a candidate clears all the stages of the Selection Procedure, then the upper age limit as on date of enrolment should be (b) 21 years.

Marital Status and Pregnancy. Only unmarried candidates (male & female) will be eligible for enrolment as Agniveervavu and they shall 6. undertake not to marry during the defined engagement period of four years. Keeping in view limited period of engagement of Agniveervayu inclusive of training, skill development activities, practical as well as formative assessment and organisational requirement of continued service of Agniveervayu during the engagement period, longer absence of Agniveervayu during the engagement period will adversely affect the operational efficiency of the Indian Air Force. Agniveervayu who marry during the said period shall be discharged from the service. Further, only unmarried Agniveervayu will be eligible for selection in regular cadre as Airman. Female candidates additionally shall be required to undertake not to get pregnant during the engagement period of four years. Such women Agniveervayu on becoming Low Medical Category (LMC) due to pregnancy shall be liable to be discharged from service. Pregnancy will debar the women Agniveervayu for selection into Regular Cadre. At the time of enrolment, candidates shall require to sign a voluntary undertaking accepting above conditions".

7. Educational Qualification

Science Subjects (a)

Candidates should have passed Intermediate/10+2/ Equivalent examination with Mathematics. Physics and English from Education Boards recognized by Central, State and UT with minimum 50% marks in aggregate and 50% marks in English.

OR

Passed Three years Diploma Course in Engineering (Mechanical / Electrical / Electronics / Automobile / Computer Science / Instrumentation Technology / Information Technology) from Central, State and UT recognized Polytechnic institute with 50% marks in aggregate and 50% marks in English in Diploma Course (or in Intermediate/Matriculation, if English is not a subject in Diploma Course)

OR

Passed Two years Vocational Course with non-vocational subject viz. Physics and Mathematics from Education Boards recognized by Central, State and UT with 50% marks in aggregate and 50% marks in English in Vocational Course (or in Intermediate / Matriculation, if English is not a subject in Vocational Course).

(b) Other than Science Subjects

Passed Intermediate / 10+2 / Equivalent Examination in any stream/subjects from Education Boards recognized by Central, State and UT with minimum 50% marks in aggregate and 50% marks in English.

Passed two years Vocational Course from Education Boards recognized by Central, State and UT with minimum 50% marks in aggregate and 50% marks in English in Vocational Course (or in Intermediate / Matriculation if English is not a subject in Vocational Course)

Note - 1: Candidates eligible for Science Subjects examination (Including Intermediate/ 10+2/three years' diploma course in engineering or two years' vocational course with non-vocational subjects of Physics and Maths) are also eligible for Other than Science Subjects and would be given an option of appearing in both Science Subjects and Other than Science Subjects examination in one sitting while filling up the online registration form

Note - 2: Education Boards recognized by Central, State and UT as on date of registrations shall only be considered.

Note - 3: Exact aggregate Percentage of marks before decimal as written in the marks sheet of 10+2/Intermediate/Equivalent Examination/Three years Diploma Course/Two years Vocational Course OR calculated as per the rules of concerned Education Board / Polytechnic Institute shall only be considered (For example 49.99% should be taken as 49% and not to be rounded off to 50%).

General Medical Standards for AGNIV/FERVAVL male & <u>Mandatory</u>

Gender (For female candidates): Any candidate if found to have predominant characteristics of the opposite gender as (k) evident on external physical examination, will be rejected as Unfit. Any candidate having undergone gender reassignment surgery will be declared Unfit

(I) Pregnancy (For female candidates): Any candidate, if found pregnant shall be disqualified and her candidature will be rejected.

Consumption of Narcotic Drugs and Psychotropic Substance (NDPS). Consumption of Narcotic Drugs and Psychotropic 9 substances banned under the NDPS Act 1985 shall be a reject criteria for selection into the IAF. AGNIVEERVAYU found either in possession or storing or distributing or consuming such drugs and substances after enrolment shall be liable for disciplinary action including dismissal from the IAF. ZERO TOLERANCE POLICY TO ALCOHOLISM AND SUBSTANCE ABUSE IS FOLLOWED IN IAF.

10. Body Tattoo. Permanent body tattoos are not permitted, however, tattoos only on inner face of the fore arms (inside of elbow to the wrist), back (dorsal) part of the hand/reverse side of the palm and Tribals with tattoo which are as per the custom and traditions of their tribes may be considered. Offensive, obscene, indecent, sexist or racist tattoos are prohibited regardless of location on the body. However, right to consider a tattoo acceptable or unacceptable will rest with the selection centre. Candidates with permanent body tattoos are to submit two Postcard size photographs (close up and distant view) with details of size and type of the Tattoo during the second phase of testing.

11. Only Sikh candidates, whose religion prohibits cutting of hair or shaving of face, shall be permitted to grow hair and/or retain beard and moustache. Accordingly, those Sikh candidates willing to retain the same as per laid down specification are to get their photographs with beard and moustache.

TERMS AND CONDITIONS

Agniveervayu will be enrolled in the Indian Air Force under Air Force Act 1950, for a period of FOUR years. Agniveervayu would form a 12. distinct rank in the Indian Air Force, different from any other existing ranks. The Indian Air Force is not obliged to retain Agniveervayu beyond the engagement period of four years.

13 On completion of four years of service, based on organisation's requirements and policies promulgated by the Indian Air Force, Agniveervayu will be offered an opportunity to apply for enrolment in the regular cadre of the Indian Air Force as Airmen. These applications will be considered in a centralised manner based on objective criteria, including performance during their four-year engagement period and up to 25% of each specific batch of Agniveervayu will be enrolled in regular cadre of IAF. Agniveervayu will not have any right to be selected for further enrolment into the Indian Air Force. Selection of the Agniveervayu for further enrolment, if any, shall be at the discretion of the Government of India.

Employability. Agniveervayu enrolled under this entry are liable to be assigned any duty in organisational interest at the discretion of the 14. Indian Air Force.

Training. On being enrolled, Agniveervayu will be imparted military training based on Indian Air Force requirements. 15.

16 Leave. Grant of leave will be subject to exigencies of the Indian Air Force. The following leave is applicable for Agniveervayu during their engagement period: -

(a) Annual Leave. 30 days per year.

(b) Sick Leave. Based on medical advice by competent Medical Authority.

Medical and CSD Facilities. For the duration of their engagement period in the Indian Air Force, Agniveervayu will be entitled for medical facility at Service Hospitals as well as CSD provisions.

Pay, Allowances and Allied Benefits. Agniveervayu enrolled under this Scheme will be paid an Agniveer package of Rs. 30,000/- per month with a fixed yearly increment. In addition, Risk and Hardship allowances (as applicable in IAF), Dress and Travel allowances will be paid. Perks such as ration, clothing, accommodation and Leave Travel Concession (LTC) shall also be provided as per the existing rules.

Terminal Benefits - Seva Nidhi Package. AGNIVEERVAYU will be given one time 'Seva Nidhi' package comprising their monthly 19. contribution along with matching contribution by the Government on completion of their engagement period, as indicated below:

Note 1: AGNIVEERVAYU will not be required to contribute to any Provident Fund in Indian Air Force.

Note 2: There shall be no entitlement to gratuity and any kind of pensionary benefits.

(a) Height:

> For Male candidates: Minimum acceptable height is 152.5 cms. (i)

For Female candidates: Minimum acceptable height is 152 cms. For candidates belonging to North East or hilly regions of (ii) Uttarakhand, a lower minimum height of 147 cms will be accepted. In case of candidates from Lakshadweep, the minimum height will be 150 cms.

Candidates availing height relaxation for being domicile of North East/Hilly Regions of Uttarakhand/Lakshadweep are to submit Note: domicile certificate with endorsement of domicile status at the time of Phase-II testing. Further, candidates from hilly regions of Uttarakhand must have specific endorsement of hilly region in their domicile certificate.

Weight: Proportionate to height and age. (b)

(C) Chest:

For Male Candidates: The chest wall should be well proportioned and well developed. Minimum chest circumference should be (i) 77 cms and the chest expansion should be atleast 05 cms.

For Female candidates: The chest wall should be well proportioned and well developed with the minimum range of expansion of 05 cms.

Hearing: Candidate should have normal hearing i.e. able to hear forced whisper from a distance of 6 meters by each ear separately. (d)

- Dental: Should have healthy gums, good set of teeth and minimum 14 dental points. (e)

Corneal Surgery (PRK/LASIK) is not acceptable. (g)

> Note: Candidates should bring prescription and spectacles for corrected vision, if being used. The latest prescription should contain diopter measurement, Ophthalmologist's registration number, stamp, signature and date of prescription should be within a month prior to appearing for medical examination.

General Health: Candidate should be of normal anatomy without loss of any appendages. He / She should be free from any active or latent, acute or chronic, medical or surgical disability or communicable disease, infection and skin ailments. Candidate shall be physically and mentally FIT to perform duty in any part of the world, in any climate and terrain.

Gynaecological Examination (For female candidates): The examination covers external genitalia, hernia orifices and the perineum, any evidence of stress urinary incontinence or genital prolapse outside introitus.

20. Insurance, Death and Disability Compensation. AGNIVEERVAYU will be provided non-contributory Life Insurance cover of Rs. 48 Lakhs for the duration of their engagement period as AGNIVEERVAYU in the Indian Air Force. AGNIVEERVAYU will not be governed by provisions contained in the Pension Regulations/Rules for Indian Air Force. For details of Death/Disability compensation log on to https://agnipathvavu.cdac.in.

'Agniveer Skill Certificate'. At the end of engagement period, a detailed Skill-Set certificate will be provided to the AGNIVEERVAYU. 21. highlighting the skills and level of competency acquired by the personnel during their engagement period.

Not Entitled to the ESM Status'. Agniveervayu enrolled under this Scheme will not be eligible for Ex-Servicemen status after their 22.' discharge from the Service on completion of four years engagement period.

Agniveervayu will not be permitted to appear in any examination for commissioning in Army/Navy/IAF during the engagement period of 23 four years unless he/she has applied for said exam before getting enrolled

24. Release at own request prior to completion of engagement period will not be permissible for Agniveervayu. However, in exceptional cases, personnel enrolled as Agniveervayu may be released, with approval of the Competent Authority.

<u> Phase - I</u>

25. Online Test. Eligible candidates will be sent admit cards for Phase - I of testing on their registered e-mail IDs between 48-72 hrs prior to the examination. Candidates are required to download the admit card, take a colour printout and carry the same to the examination centre. Name of city & exam date will be intimated to the candidates at an earlier date to enable them to plan their movement. This provisional admit card can also be downloaded by the candidate under candidates login on CASB web portal https://agnipathvayu.cdac.in. All candidates in possession of provisional admit card will undertake Online Test at centres designated / allotted as per their admit card. Online test will be objective type and questions will be bilingual (English & Hindi) except for English paper. Candidates are to bring one blue / black pen and original AADHAAR card along with them for Phase - I testing. Details of the test are as follows: -

Science Subjects. Total duration of the online test shall be 60 minutes and shall comprise of Physics, Mathematics and English as per 10+2 CBSE syllabus.

Other than Science Subjects. Total duration of the online test shall be 45 minutes and shall comprise of English as per 10+2 CBSE syllabus and Reasoning & General Awareness (RAGA).

Science Subjects & Other than Science Subjects. Total duration of the online test shall be 85 minutes and shall comprise of Physics, Mathematics and English as per 10+2 CBSE syllabus and Reasoning & General Awareness (RAGA).

- (d) Marking pattern for online test: -
 - One mark for every correct answer.
 - Nil (0) marks for unattempted question. (ii)
 - (iii) 0.25 marks shall be deducted for each wrong answer

Note: Above examination methodology has been designed to facilitate selection process based on qualifications of candidates. Irrespective of the examination methodology AGNIVEERVAYU enrolled under this entry are liable to be assigned any duty in organisational interest, at the discretion of the Indian Air Force.

26. Marks scored by the candidates in STAR Phase-I Testing will be "Normalised" by using the formula as published on the web site https://agnipathvayu.cdac.in, to take into account variation in difficulty levels of the question papers across different sessions. Candidates are to note that the application of Cut-Off for shortlisting of candidates for STAR Phase-II testing and preparation of Final Merit List for selection will be based on "Normalised Marks" and not on the "Actual Marks" scored by the candidate in STAR Phase-I testing. Further, on normalisation, marks scored by a candidate in a subject may become less/more than actual marks, and more than total marks of that subject in exceptional cases.

CANDIDATES ARE TO QUALIFY IN EACH PAPER INDIVIDUALLY IN SCIENCE SUBJECTS AND OTHER THAN SCIENCE SUBJECTS, with normalised marks. The result of Phase-I and shortlisting for Phase-II, based on their performance in Phase-I Online test, will be uploaded in candidate's individual log in ID on https://agnipathvayu.cdac.in

Phase - II

Soon after the declaration of the result of Phase-I (Online) Test, a cut off will be applied on the normalised marks scored by the 28. candidates in the Phase-I Test and SHORTLISTED candidates will be sent a New admit card on their registered e-mail IDs for Phase-II test at a designated ASC. This admit card for Phase-II exam can also be downloaded online under candidate's login on CASB web portal https://agnipathvayu.cdac.in. Candidates have to report on the stipulated date and time for Phase-II at the designated ASC along with following:-

- Colour print out of Phase-II admit card. (a)
- Colour print out of duly filled application form downloaded on completion of online registration. (b)
- HB pencil, eraser, sharpener, glue stick, stapler and black/blue ball point pen for writing. (c)
- (d) Eight copies of un-attested passport size colour photograph (which was used for the online application registration).
