#### BHABHA ATOMIC RESEARCH CENTRE (BARC)

The Bhabha Atomic Research Centre (BARC) is India's premier nuclear research facility, headquartered in Trombay, Mumbai, Maharashtra. BARC is a multi-disciplinary research centre with extensive infrastructure for advanced research and development covering the entire spectrum of nuclear science, engineering and related areas.

BARC's core mandate is to sustain peaceful applications of nuclear energy, primarily for power generation. It manages all facets of nuclear power generation, from the theoretical design of reactors to, computerized modeling and simulation, risk analysis, development and testing of new reactor fuel materials, etc. It also researches spent fuel processing and safe disposal of nuclear waste. Its other research focus areas are applications for isotopes in industries, medicine, agriculture, etc. BARC operates a number of research reactors across the country.

The Government of India created the Atomic Energy Establishment, Trombay (AEET) with Homi J. Bhabha as the founding director on 3 January 1954. It was established to consolidate all the research and development activities for nuclear reactors and technology under the Atomic Energy Commission. All scientists and engineers engaged in the fields of reactor designing and development, instrumentation,

metallurgy, and material science, etc., were transferred with their respective programs from the Tata Institute of Fundamental Research (TIFR) to AEET, with TIFR retaining its original focus for fundamental research in the sciences. After Homi Jehangir Bhabha's death in 1966, who is also known as the "Father of Indian Nuclear Programme", the centre was renamed as the Bhabha Atomic Research Centre on 22 January 1967.

The primary importance of BARC is as a research centre. The BARC and the Indian government has consistently maintained that the reactors are used for this purpose only: Apsara (1956; named by the then Prime Minister of India, Jawaharlal Nehru when he likened the blue Cerenkov radiation to the beauty of the Apsaras), CIRUS (1960; the "Canada-India Reactor" with assistance from the US), the now-defunct ZERLINA (1961; Zero Energy Reactor for Lattice Investigations and Neutron Assay), Purnima I (1972), Purnima II (1984), Dhruva (1985), Purnima III (1990), and KAMINI.

The plutonium used in India's 1974 Smiling Buddha nuclear test came from CIRUS. The 1974 test (and the 1998 tests that followed) gave Indian scientists the technological know-how and confidence not only to develop nuclear fuel for future reactors to be used in power generation and research but also the capacity to refine the same fuel into weapons-grade fuel to be used in the development of nuclear weapons.



#### 3. SELECTION METHOD

#### 3.1 Technical Officer/C

Selection will be on the basis of performance in interview. In case, the response is more, this Centre reserves the right to restrict the number of candidates to be called for interview by conducting Computer Based Screening Test in the concerned discipline on all India basis. The decision of this Centre in this regard will be final.

#### 3.2 Scientific Assistant/B and Category-I Stipendiary Trainee

The Computer Based Screening Test of one hour duration will be conducted on all India basis and will comprise of 40 multi choice questions (choice of 4 options). '3' marks will be awarded for each correct answer and '1' mark will be deducted for each incorrect answer. The syllabus for the said examination will be based on subjects at Diploma / B.Sc. level as the case may be. Those candidates qualifying in the Screening Test shall be shortlisted for interview. The venue of interview will be intimated later.

Final selection will be on the basis of performance of the candidate in interview and **no weightage** will be given for marks scored in the Screening Test. The decision of this Centre in this regard will be final.

#### 3.3 Technician/B and Category-II Stipendiary Trainee

The Selection Process consists of Tests in three stages – Stage 1 – Preliminary Test

Stage 2 – Advanced Test Stage 3 – Skill Test.

The Computer Based Test will be conducted on all India basis for Stage 1 – Preliminary Test and Stage 2 – Advanced Test for concerned trade in a single Session. However, the evaluation of Stage 2 – Advanced Test will be carried out only of those candidates qualified in the Stage 1 – Preliminary Test.

#### Stage 1 - Preliminary Test

 Screening Test consisting of 50 multi choice questions (choice of 4 options) of one hour duration in the following proportion:

Mathematics – 20 questions Science – 20 questions General awareness – 10 questions

'3' marks will be awarded for each correct answer and '1' mark will be deducted for each incorrect answer.

 All candidates with less than 40% in general category and less than 30% in reserved category will be screened out

#### Stage 2 - Advanced Test

- The Test will comprise of 50 multi choice questions (choice of 4 options) of two hours duration.
- '3' marks will be awarded for each correct answer and '1' mark deducted for each incorrect answer.
- Merit List of candidates will be prepared after Stage-2, based upon the scores obtained in Stage-2 only.
- All candidates with less than 30% in general category and less than 20% in reserved category will be screened out.

#### Stage 3 - Skill Test

- The number of candidates shortlisted for Skill Test will depend upon the number of candidates qualifying for Stage 2 but will not exceed 4 to 5 times the number of vacancies in each trade.
- The Skill Test will be based on Go/No-Go basis.
- Based upon the Merit List prepared after Stage 2 Advanced Test, candidates will be shortlisted for Stage 3. Candidates clearing the Skill Test will be shortlisted and empanelled in order of Merit based on the marks secured in Stage 2 – Advanced Test.

Resolutions in the Event of tie in Empanelment Criteria in the following order:

- Candidate with Lower negative marks in Stage 2 to be placed higher on the Merit List.
- Candidate with Higher marks in Stage 1 to be placed higher on the Merit List.
- Candidate with Lower negative marks in Stage 1 to be placed higher on the Merit List.
- Candidate with Higher positive marks in Mathematics in Stage 1 to be placed higher on the Merit List.
- Candidate with Higher positive marks in Science in Stage 1 to be placed higher on the Merit List.

Note: There shall be no provision for re-evaluation/ re-checking of the scores of any stage of the Tests. No correspondence in this regard will be entertained.

#### 4. HOW TO APPLY

- 6.2 Candidates may indicate their choice of city (nearer to their present address) in their application form in the order of preference (only three cities). Candidate must ensure that their date of birth (DD/MM/YYY) mentioned in the application match with the valid ID Proof, failing which, the candidate will not be allowed to appear in the Computer Based Test. Any other document mentioned in the Admit Card shall also be carried by the candidates while appearing in the Computer Based Test.

#### 8. DOCUMENT VERIFICATION (DV)

- 8.1 Candidates would be required to produce all the relevant following certificates in original along with their copies and print out of online application at the time of document verification prior to Interview / Skill Test. The candidates will be solely responsible for furnishing the requisite certificates, failing which their candidature shall be summarily rejected. Candidates may also note that their candidature will remain provisional till the verification of veracity of the documents by the Appointing Authority.
- (a) Educational qualifications supported by appropriate mark sheets/certificates as proof of possessing the minimum educational qualification as on the closing date, failing which the candidature of such candidate will be cancelled.

- (e) OBC for the purpose of AGE RELAXATION AND RESERVATION means "persons of OBC categories not belonging to the Creamy Layer" as defined in Government of India, Department of Personnel & Training OM No.36012/22/93-Estt.(SCT) dated 08.09.93 and modified vide Government of India, Department of Personnel & Training OM No.36033/3/2004-Estt.(Res.) dated 09/3/2004, OM No. 36033/3/2004-Estt.(Res.) dated 14/10/2008, OM No. 36033/1/2013-Estt (Res.) dated 27/05/2013 and latest modification vide Government of India, Department of Personnel and Training OM No. 36033/1/2013-Estt (Res.) dated 13/09/2017.
- (f) Candidates who are not covered under the scheme of reservation for SC / ST / OBC and whose family gross annual income is below Rs.8 Lakh (Rupees Eight Lakh) are to be identified as EWS for benefit of reservation for EWS. The income shall also include income from all sources i.e. salary, agriculture, business, profession etc. for the financial year prior to the year of application in accordance with DoPT OM No. 36039/1/2019-Estt.(Res) dated 31/01/2019, 11/06/2019 and No.43011/11/2022-Estt.(Res-II) dated 19/09/2022. The Income and Asset Certificate issued in the prescribed format as given in Annexure C shall only be accepted as proof of candidate's claim as belonging to EWS.

- (g) Disability Certificate from the appropriate authority regarding physical disability (as per the formats given in **Annexure D & E** applicable only for Persons with Disability)
  - (i) According to the persons with disabilities (Equal Opportunities, Protection of Rights and Full Participation) Rules, 1996 notified on 31/12/1996 by the Central Government in exercise of the powers conferred by sub-section (1) and (2) of Section 73 of the Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act, 1995 (1 of 1996)], a disability certificate shall be issued by a Medical Board duly constituted by the Central or a State Government. The Central/State Government may constitute a Medical Board consisting of at least three members, out of which, at least, one member shall be a Specialist from the relevant field.
  - (ii) The certificate would be valid for a period of 5 years for those whose disability is temporary. The Medical Board shall indicate the period of validity of the certificate where there are chances of variation in the degree of disability. For those who acquired permanent disability, the validity can be shown as permanent. On representation by the applicant, the Medical Board may review its decision having regard to all the facts and circumstances of the case and pass such orders in the matter as it thinks fit.
- (h) In case of persons with benchmark disabilities in the category of blindness (low vision), the facility of scribe is provided, if desired by the candidate. In case of remaining categories of persons with benchmark disabilities, the provision of scribe will be available on production of a certificate at the time of examination to the effect that the person concerned has physical limitation to write, and scribe is essential to write examination on candidate's behalf, from the Chief Medical Officer / Civil Surgeon / Medical Superintendent of a Government health care institution as per proforma at Annexure F.
- (i) Engagement of Scribe will be subject to the following conditions:
  - (i) Candidates will have to arrange for the scribe on their own.
  - (ii) The scribe so arranged should not himself/herself be the candidate for post / vacancies / exam for which the candidate is appearing. Also same scribe should not be engaged for more than one candidate. The scribe and the candidate shall give a declaration to this effect. Any violation, if detected at any stage will render both the candidate & the Scribe disqualified.
  - (iii) Candidates with disabilities which are not identified as eligible for concession are not allowed to have scribe
  - (iv) In case the candidate opts for his/her own scribe, the qualification of the scribe should be one step below the qualification of the candidate taking the examination. The candidates with benchmark disabilities opting for own scribe shall be required to submit details of the own scribe at the time of examination as per proforma at Annexure G. In addition, the scribe has to produce a valid ID proof in original at the time of examination. A photocopy of the ID proof of the scribe signed by the candidate as well as the scribe will be submitted along with proforma at Annexure G. If, subsequently it is found that the qualification of the scribe is not as declared by the candidate, then the candidate shall forfeit his/her right to the post and claims relating thereto.
  - (v) Candidates opting for scribe will have to provide details of scribe as per Annexure G which should be signed by both candidate and scribe at the time of exam. Scribe should produce original valid ID proof at exam centre, and paste passport size photograph on Annexure G.
  - (vi) The persons with benchmark disabilities who are allowed to take examination on computer system, are allowed to check the computer system one day in advance so that the problems, if any in the software/system could be rectified. Use of own computer/laptop is not allowed for taking examination. However, enabling accessories for the computer based examinations such as keyboard, customized mouse etc. is allowed.
  - (vii) The candidate shall be responsible for any misconduct on the part of the scribe brought by him/her during the examination.
- (j) A compensatory time of 20 minutes per hour of examination will be provided to the Persons with Benchmark Disability.
- (k) No attendant other than the scribe for eligible candidates will be allowed inside the Examination Hall.
- (I) The PwBD candidates who have availed the facility of scribes / passage reader and / or compensatory time must produce relevant documents for the eligibility of scribe/ compensatory time at the time of Document Verification. Failure to produce such supporting documents will lead to cancellation of their candidature for the examination.
- (m) One eyed candidates and partially blind candidates who are able to read the normal Question Paper set with or without magnifying glass and who wish to indicate the answer with the help of magnifying glass will be allowed to use the same in the Examination Hall and will not be entitled to a scribe. In addition to entry pay, allowances will be admissible under Central Government Rules.

#### 11.3 Bond

Selected candidates will have to execute a bond to complete the training and to serve constituent Units of DAE for a period of 3 years after absorption. A trainee who fails to complete the training or/and serve the Department for 3 years after absorption, will be liable to pay to the Government a sum equivalent to aggregate amount of stipend and book allowance received by him / her during the period of training along with interest thereon.

#### 12. GENERAL CONDITIONS
